## Requirements:

- 1. The boat must be fully **Comprehensively Insured** including Public Liability of at least \$10,000.000.00 must be in place covering the specific vessel.
- 2. Contractors/outside Tradesmen on-site must have appropriate Public Liability insurance of at least \$5,000,000.00 and current Workers Compensation cover. Proof of these must be provided to Marina Management prior to works commencing. Contractors/outside Tradesman can only work at the Marina with prior approval of Marina Management. Outside contractors may pay a fee of \$250.00 per day per trade to work at Yamba Marina.
- 3. Yamba Marina Pty Ltd accepts no responsibility whatsoever for any damage to any vessel or person regarding the operation of the travelift, hardstand and marina equipment and facilities. By signing this agreement, the vessel owner (or nominee) specifically recognises that Yamba Marina Pty Ltd and staff are not responsible for any damage to ANY BOAT, or any injury suffered by any client, whatsoever.
- 4. Yamba Marina is a private facility and retains all rights to deny access to the Marina property to any person, vehicle, or vessel.
- 5. All works carried out on site must be in full accord with the requirements or directions of the **Environmental Protection Authority (EPA)** and the Local Council and NSW State Government.
- 6. No maintenance work is to be carried out on boats berthed in the floating section of the marina. For clarity this includes all external works other than hosing down the boat with fresh water.
- 7. Any washing or cleaning down of vessels or other work must be managed in a manner which prevents the return of any residues or pollutants to the adjacent waters.
- 8. Any works having the potential to create dust (i.e. grinding, sanding etc) must be adequately screened. All dust must be vacuum extracted, and the work must be approved by the Yard Manager. No exceptions.
- 9. Any spray painting must be adequately screened to prevent drift. Marina management has sole discretion as to the adequacy of screening. No spray painting is to be undertaken with a wind speed of more than 5km/h from any direction.
- 10. Containers of any Oils, Paints, Solvents, Acids, or the like must remain adequately capped to prevent accidental spillage. Any spillage must be contained and tendered to immediately and the incident reported to the Marina Manager or his representative.
- 11. All noise must be kept to a minimum and within the bounds of requirements of the EPA and/or the local Council and NSW State Givernment.
- 12. The site must be kept clean. All residues, waste and rubbish must be removed from the site to the satisfaction of Marina Management.
- 13. No alcohol or illegal drugs to be consumed at any time in work areas or other public areas of the marina.
- 14. No props are to be moved. No changes to cradles without specific approval of the yard manager. No exceptions.
- 15. By signing this agreement, I understand I am liable for all charges incurred and I authorise Yamba Marina to charge my credit card for all charges.
